

**LibertyX Winter Wealth Bitcoin Giveaway,
OFFICIAL RULES**

NO PURCHASE NECESSARY

SWEEPSTAKES DESCRIPTION: The LibertyX Sweepstakes (the “**Sweepstakes**”) runs for twelve (12) weeks and will consist of twelve separate weekly Sweepstakes beginning on December 16, 2025 at 12:00:01 a.m. Eastern Time (“**ET**”) and ending on March 9, 2026 at 11:59:59 p.m. ET (the “**Sweepstakes Period**”). Each of the twelve (12) weeks constitutes a separate weekly entry period with its own drawing. Entries that do not win during the week in which they are submitted will not carry over to subsequent weekly drawings.

Weekly entry periods (each, a “**Weekly Entry Period**” and collectively, “**Weekly Entry Periods**”) will take place as follows:

Participation in the Sweepstakes does not constitute participation in any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Moon Inc. dba LibertyX, 864 Spring St. NW, Atlanta, GA 30308 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: The Sweepstakes is only open to legal residents of the United States (excluding Alaska, Rhode Island, Vermont, Puerto Rico and U.S. Territories and possessions) and the District of Columbia who are at least eighteen (18) years of age and the age of majority in their state of residence (nineteen (19) in Alabama and Nebraska and eighteen (18) in all other states). Employees, officers, owners, managers, and directors of Sponsor, its parent, subsidiaries, affiliates, vendors, distributors, suppliers, advertising/promotion/marketing agencies, social media influencers (collectively, the “**Sweepstakes Entities**”) and the immediate family members, and/or those living in the same household of each are prohibited from participating in the Sweepstakes or winning a prize. Sweepstakes is void in Alaska, Rhode Island, Vermont, Puerto Rico and U.S. Territories and possessions and where prohibited by law.

HOW IT WORKS:

There are two (2) ways to enter the Sweepstakes:

1. **Via Transaction:** To enter the Sweepstakes via a transaction, you must have the LibertyX App (the “App”). If you don’t have the App, you can download it for free from the App Store or Google Play. Once you have the App, you must follow the instructions to set up an account in the App including completing the verification process through KYC authentication and opt-in to participate in the Sweepstakes. Thereafter, you will automatically receive entries into the Sweepstakes for each transaction you conduct in the App during the Sweepstakes Period. Entries will be earned as follows: a) each LibertyX Transaction less than \$100 = 1 entry into the Weekly Entry Period drawing corresponding to the date of the transaction; b) each LibertyX Transaction between \$100 - \$199.99 = 2 entries into the Weekly Entry Period drawing corresponding to the date of the transaction; c) each LibertyX Transaction over \$200 = 5 entries into the Weekly Entry Period drawing corresponding to the date of the transaction, and d) each LibertyX Cashout Transaction Bonus (limit one per week) = 100 entries into the Weekly Entry Period drawing corresponding to the date of the transaction.
2. **NO PURCHASE NECESSARY.** To enter without making a purchase (the “AMOE”), during the Sweepstakes Period, go to the LibertyX home page (www.LibertyX.com) or App, create an account, and complete the optional questionnaire as part of the Opt-in process to earn ten (10) entries into the Weekly Entry Period drawing corresponding to the date of the questionnaire completion. The questionnaire must be completed by the deadline in the chart above corresponding to the Weekly Entry Period to be entered in that Weekly Entry Period. For each subsequent Weekly Entry Period, The AMOE entrant will receive one (1) entry for each Drawing.

Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with Sponsor’s Privacy Policy located at <https://libertyx.com/docs/privacy>.

The Sponsor reserves the right, in its sole and absolute discretion, to void any Entries for any reason, including, but not limited to, suspected fraud, deception, or other improper conduct.

The Sweepstakes Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. The Sweepstakes Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. NOTE: Participation must be by the participant and only as directed in these Official Rules. Participation by any other individual or any entity, and/or originating at any website or other platform, including but not limited to commercial promotion subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited and will lead to disqualification.

In the event of a dispute over the identity of an entrant, entry will be deemed completed by the authorized account holder of the email address provided at time of transaction/registration, as long as such person is otherwise eligible in compliance with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, on-line service provider, wireless carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

WINNER SELECTION AND NOTIFICATION: On or about each of the dates indicated in the chart above, the potential sweepstakes prize winner(s) for the corresponding Weekly Entry Period will be randomly selected by representatives of Sponsor from all eligible entries received in accordance with the deadlines stated herein. The potential winners will be notified via the App or

by telephone and/or e-mail, using contact information provided or collected at the time of entry, as applicable. Potential winners will receive instructions on how to claim their prize within the App. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond or claim their prize within forty-eight (48) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit their prize and an alternate sweepstakes prize winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential sweepstakes prize winners in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed.
